In The Matter Of FRANCOIS HARAVEY, M.D.

CONSENT ORDER

The Louisiana State Board of Medical Examiners brought charges against FRANCOIS HARAVEY, M.D. for violations of the Louisiana Medical Practice Act, to-wit: "prescribing, dispensing, or administering habit-forming or other legally controlled substances in other than a legal or legitimate manner," LSA-R.S. 37:1285(6), and "unprofessional conduct," LSA-R.S. 37:1285(13). Such charges were based upon written findings of fact, conclusions of law and decision rendered May 17, 1976 by the Division of Medical Quality of the Board of Medical Quality Assurance of the State of California in the matter of The Accusation against Francois Haravey, M.D., No. D-1633, L-9804, a copy of which is annexed hereto and made a part hereof. By formal notice issued March 11, 1977, Dr. Haravey was apprised of the charges and of formal hearing thereon, pursuant to LSA-R.S. 49:955-61, to be convened on April 21, 1977 at the Board offices.

By these presents, witnessed by the notarized acknowledgment hereinafter set forth, Francois Haravey, M.D., expressly acknowledges and admits his violation of LSA-R.S. 37:1285(6) and (13); waives his right to formal hearing and the reception of evidence thereon; and hereby expressly consents to entry of the following

consent order.

Order

Considering the foregoing,

IT IS ORDERED that the license of FRANCOIS
HARAVEY, M.D., to practice medicine in the State of
Louisiana, as evidenced by Certificate No. 9338,
be and the same is hereby suspended until June 16,
1986;

IT IS FURTHER ORDERED that the foregoing Order of Suspension be, and the same is hereby, suspended; PROVIDED, however, that Francois Haravey, M.D., accept and comply with the following probationary terms and conditions:

- (a) Dr. Francois Haravey shall strictly observe and comply with all of the probationary terms and conditions imposed by the Division of Medical Quality of the Board of Medical Quality Assurance, State of California by its decision rendered May 17, 1976;
- (b) Dr. Francois Haravey shall authorize the Division of Medical Quality and the officers thereof to render periodic reports to the Louisiana State Board of Medical Examiners relative to his compliance with the probationary terms and conditions of the said decision of May 17, 1976;
- (c) Dr. Francois Haravey shall submit to the Louisiana State Board of Medical Examiners duplicate original or certified copies of the reports, affidavits and certificates he is required to submit pursuant to conditions "1" and "5" of the aforesaid decision of the Division of Medical Quality, on the same dates and at the same intervals as provided therein;
- (d) Dr. Francois Haravey shall give the Louisiana State Board of Medical Examiners written notice of his intention to return to the active practice of medicine in the State of Louisiana

at least twenty (20) days in advance of the first day on which such practice is to begin.

PROVIDED FURTHER that the probationary terms and conditions imposed herein, as well as those adopted or incorporated by reference from the decision and order of the Division of Medical Quality, may be maintained in full force and effect by the Louisiana State Board of Medical Examiners throughout the period of suspension hereinabove ordered, regardless of any subsequent modification, amendment or annulment of the aforesaid order of the Division of Medical Quality; and provided further that violation of any of the probationary terms as hereinabove set forth without justifiable cause therefor to be determined in the sole and absolute discretion of the Board, shall result in automatic reinstatement of the Order of Suspension.
