THE APPLICATION OF ASHLEY E. ROE, CLS-SPECIALIST (Applicant) CONSENT ORDER FOR ISSUANCE OF LICENSE WITH REPRIMAND

This matter is before the Louisiana State Board of Medical Examiners (the "Board") on the application of Ashley Elizabeth Roe ("Ms. Roe") for a license to practice as a Clinical Laboratory Scientist Specialist ("CLS-S") in this state. While a review of the materials submitted in support of her application indicates that she satisfies the educational and other requirements necessary for licensure consideration, Ms. Roe reports that she has been working as a laboratory assistant in Louisiana without a license.

In connection with this matter, Ms. Roe admits that she has worked as an unlicensed laboratory assistant in Shreveport since April 2016. She explained that she was unaware that a laboratory assistant license was required to perform her assigned job responsibilities. Ms. Roe acknowledged that her prior understanding was in error and she now accepts her responsibility to understand and comply with all rules and regulations regarding licensure in this state.

As evidenced by her subscription to this Order, Ms. Roe acknowledges the substantial accuracy of the foregoing information and that proof of such information upon administrative evidentiary hearing could establish sufficient cause for the rejection or denial of her application for licensure in this state or such other action as the Board may deem appropriate, pursuant to the Law and/or the Board's rules respecting clinical laboratory personnel.

Investigation of the captioned matter was assigned to the Investigating Officer ("I/O") for the Board. While it appears to the I/O that Ms. Roe is a conscientious and well-trained clinical laboratory assistant, the I/O's review and analysis of the matter confirms to her satisfaction that sufficient cause exists to charge Ms. Roe with one or more violations of the Louisiana Clinical Laboratory Personnel Law (the "Law"), La. Rev. Stat. §37:1318, 1326 and/or the Board's rules respecting clinical laboratory personnel, La. Adm. C. 46XLV.3505.

Recognizing her right to have administrative adjudication of the above charges, at which time she would be entitled to be represented by legal counsel, to call witnesses and to present evidence on her own behalf in defense or in mitigation of the charges made and to a decision thereon by the Board based upon written findings of fact and conclusions of law, pursuant to La.

Rev. Stat. §§49:951, et seq., Ms. Roe, nonetheless, hereby waives her right to notice of charges, formal adjudication and written decision and, pursuant to La. Rev. Stat. §49:955(D), consents to entry of the Order set forth hereinafter. Moreover, by her subscription hereto, Ms. Roe also waives any right to which she may be entitled pursuant to the Louisiana Administrative Procedure Act2 or which otherwise may be afforded to her by law, to contest her agreement to or the force and effect of this document in any court or before any judicial or administrative agency or body, relating to the matters referred to herein. By her subscription hereto, Ms. Roe also hereby authorizes the Investigating Officer designated by the Board with respect hereto to present this Consent Order to the Board for its consideration and to fully disclose to and discuss with the Board the nature and results of the investigation, and she waives any objection to such disclosures under La. Rev. Stat. §49:960. Furthermore, Ms. Roe expressly acknowledges that the disclosure of information to the Board by the Investigating Officer shall be without prejudice to the Investigating Officer's authority to pursue any Administrative Complaint filed against her or to the Board's capacity to adjudicate such Complaint, should the Board decline to approve this Consent Order. Accordingly, in consideration of the foregoing, and pursuant to the authority vested in the Board by La. Rev. Stat. §37:1326 and La. Rev. Stat. §49:955D;

IT IS ORDERED that Ashley Elizabeth Roe is hereby OFFICIALLY REPRIMANDED for the conduct asserted hereinabove.

IT IS FURTHER ORDERED that after completion of application requirements, a license to practice as a clinical laboratory scientist specialist in the state of Louisiana shall be issued to Ashley Elizabeth Roe.

IT IS FURTHER ORDERED that within six (6) months of the date of this Order, Ms. Roe shall pay the Board a fine in the amount of Eighty Dollars (\$80.00), which represents the license renewal fees for one (1) year, plus a penalty of an equal amount.

IT IS FURTHER ORDERED that any violation or failure of strict compliance with this Order by Ms. Roe shall be deemed adequate and sufficient cause, upon proof of such violation or failure, for such disciplinary action as the Board deems appropriate, as if such violations were enumerated among the causes provided in La. Rev. Stat. §37:1326.

IT IS FURTHER ORDERED that this Consent Order shall be, and shall be deemed to be, a public record.
