The above-entitled proceeding was docketed for investigation by the Louisiana State Board of Medical Examiners (the "Board") regarding Kayla Simone Terrell ("Ms. Terrell"), a CLP (Clinical Laboratory Personnel) who is, and was, at all times material to the facts and matters alleged herein, licensed by the Board as a CLP and employed and working as a CLP in the state of Louisiana pursuant to the Louisiana Clinical Laboratory Personnel Law, ("CLP Act"), La. R.S. 37:1311-1329. The investigation was initiated following the receipt of apparently reliable information indicating that Ms. Terrell failed to report a June 11, 2018 arrest on her renewal application in violation of the CLP Act. The Board attempted to contact Ms. Terrell by phone, by e-mail, and by certified mail, but Ms. Terrell, in violation of the CLP Act, failed to respond to the Board's numerous inquiries until December of 2019, when she was unable to renew her CLP license.

Ms. Terrell has now cooperated with the Board, met with the Director of Investigations, and acknowledged that the foregoing information could provide the Investigating Officer for the Board with probable cause to pursue formal administrative proceedings against her for violations of the CLP Act, La. R.S. 37:1326(A)(6) and (7),<sup>1</sup> constituting sufficient cause for the revocation, suspension or such other action against her license to practice in the state of Louisiana as the Board may determine appropriate.

Recognizing her right to notice and administrative adjudication of any charges that may be asserted against her in these proceedings, at which time Ms. Terrell would be entitled to be represented by legal counsel, to call witnesses and to present evidence on her own behalf in defense or in mitigation of the charges made and to a decision thereon by the Board based upon written

R.S. 37:1326A The board, upon the recommendation of the committee, may deny, suspend, probate, restrict, or revoke the issuance or renewal of a license or certificate, after notice and an opportunity for a hearing pursuant to the Administrative Procedure Act, upon a preponderance of evidence showing any of the following when such activity is not authorized by the provisions of this Part: '(6) Fraud or deceit in procuring or attempting to procure a license or certificate to engage in the practice of clinical laboratory science.'; '(7) Violating or helping someone else violate any provision of this Part or any rule or regulation promulgated hereunder.'

findings of fact and conclusions of law pursuant to La. R.S. 49:955–65, Ms. Terrell, nonetheless, hereby waives her right to notice and formal adjudication and pursuant to La. R.S. 49:955(D), consents to entry of the Order set forth hereinafter. Ms. Terrell acknowledges that she hereby waives any right to which she may be entitled pursuant to the Louisiana Administrative Procedure Act, La. R.S. 49:951 *et seq.*, or which may be afforded to her by any other law to contest or appeal her agreement to or the force and effect of the Board’s investigation or this Order in any court or other forum. By her subscription hereto, Ms. Terrell also hereby authorizes the Investigating Officer designated by the Board with respect hereto to present this Order to the Board for its consideration and to fully disclose to and discuss with the Board the nature and results of the investigation and she waives any objection to such disclosures under La. R.S. 49:960. Ms. Terrell expressly acknowledges that the disclosure of such information to the Board by the Investigating Officer shall be without prejudice to the Investigating Officer’s authority to proceed with the adjudication of an administrative complaint against her or to the Board’s capacity to adjudicate such complaint should the Board decline to approve this Order. Accordingly, in consideration of the foregoing and pursuant to the authority vested in the Board by La. R.S. 37:1326, La. R.S. 49:955(D).

**IT IS ORDERED** that Kayla Simone Terrell is hereby **OFFICIALLY REPRIMANDED** for her conduct.

**IT IS FURTHER ORDERED** that the Ms. Terrell shall, within one hundred and twenty (120) days of the date of this Order, complete twenty-five (25) hours of Board approved community service.


**IT IS FURTHER ORDERED** that any violation or failure of strict compliance with any of the terms, conditions or restrictions set forth by this Order by Ms. Terrell shall be deemed adequate and sufficient cause, upon proof of such violation or failure, for such other action against Ms. Terrell’s license to practice as a CLP in the state of Louisiana as the Board may deem appropriate, as if such violations were enumerated among the causes provided in La. R.S. 37:1326(A).

**IT IS FURTHER ORDERED** that this Consent Order shall be, and shall be deemed to be, a public record.
