CONSENT ORDER

The Louisiana State Board of Medical Examiners (the "Board") has received reliable information that Latresia Ann Wilson, M.D. ("Dr. Wilson"), a physician who at all times pertinent hereto has been licensed by the Board, as evidenced by Credential No. MD.202401, and who was engaged in the practice of medicine in and around Marion County, Florida, entered a plea of guilty to one count of conspiracy to defraud the United States and to purchase, sell, and distribute Medicare beneficiary identification numbers in violation of Title 18 U.S.C. § 371, a felony under the laws of the United States.¹

Specifically, from in or around July 2022, through in or around February 2023, Dr. Wilson conspired to defraud the United States by submitting false and fraudulent claims to Medicare for over-the-counter COVID-19 tests that were medically unnecessary and ineligible for reimbursement.² Dr. Wilson is currently scheduled to be sentenced on February 6, 2025.³

Predicated upon the foregoing information, the Board's Investigating Officer has determined that sufficient cause exists to file formal charges against Dr. Wilson for violations of the Louisiana Medical Practice Act (the "Act"), pursuant to La. R.S. 37:1285(A)(1) and (2).⁴

As evidenced by her subscription hereto, Dr. Wilson acknowledges that the information developed by the Board's investigation would constitute sufficient cause for the institution of administrative proceedings against her medical license and that proof of such information upon

administrative evidentiary hearing could establish grounds under the Act for the suspension or revocation of her license to practice medicine in the State of Louisiana, or for such other action as the Board might deem appropriate.

Recognizing her right to have notice and administrative adjudication of any charges that may be filed in this matter, at which time Dr. Wilson would be entitled to be represented by legal counsel, to call witnesses and to present evidence on her own behalf in defense or in mitigation of the charges made and to a decision thereon by the Board based upon written findings of fact and conclusions of law, pursuant to La. R.S. 49:950 *et seq.*, Dr. Wilson, nonetheless, hereby waives her right to notice of charges, formal adjudication and written decision and pursuant to La. R.S. 49:975(D), consents to entry of the Order set forth hereinafter. Moreover, by her subscription hereto, Dr. Wilson also waives any right to which she may be entitled pursuant to the Louisiana Administrative Procedure Act, La. R.S. 49:950 *et seq.*, or which otherwise may be afforded to her by law to contest her agreement to or the force and effect of the Board's investigation or this document in any court or other forum or body relating to the matters referred to herein. By her subscription hereto, Dr. Wilson also hereby authorizes the Investigating Officer designated by the Board with respect hereto to present this Consent Order to the Board for its consideration and to fully disclose to and discuss with the Board the nature and results of the investigation and she waives any objection to such disclosures under La. R.S. 49:977.2. Further, Dr. Wilson expressly acknowledges that the disclosure of such information to the Board by the Investigating Officer shall be without prejudice to the Investigating Officer's authority to proceed with the filing and adjudication of an Administrative Complaint against her, or to the Board's capacity to adjudicate any charges that may be filed in this matter should the Board decline to approve this Order.

Based upon the information provided, accordingly, and upon the recommendation of the Investigating Officer assigned to this matter, the Board has concluded that its responsibility to ensure the health, safety, and welfare of the citizens of this state, pursuant to La. R.S. 37:1261, will be effectively served by entry of the Order set forth hereinafter by consent. Accordingly, in consideration of the foregoing, and pursuant to the authority vested in the Board by La. R.S. 37:1285 and La. R.S. 49:975(D);

IT IS ORDERED that the license of Latresia Ann Wilson, M.D., to practice medicine in the State of Louisiana, as evidenced by Credential No. MD.202401, is hereby placed on **INDEFINITE SUSPENSION**.

IT IS FURTHER ORDERED that the reissuance or reinstatement of Dr. Wilson's license to practice medicine in the State of Louisiana shall be subject to her acceptance of and strict compliance with the following terms, conditions, and restrictions:

1. **Suspension; Reissuance/Reinstatement.** Dr. Wilson shall not practice medicine in the State of Louisiana until and unless the Board issues and serves on her a written order reissuing or reinstating her medical license. As express conditions to Dr. Wilson's petition or request of the Board for such an order, Dr. Wilson shall have: (1) either (a) been released from any period of incarceration and successfully completed any period of probation/supervised release imposed by the Court as a result of the above mentioned criminal plea or (b) received a court order vacating or otherwise permitting her to withdraw her guilty plea; (2) scheduled and met with the Investigating Officer of the Board to discuss her then-current status and plans for resumption of practice; (3) satisfied the eligibility and other requirements of the Board's rules governing license

issuance or reinstatement as of the date of her petition or request, La. Admin. Code tit. 46, pt. XLV, ch. 3; and (4) demonstrated to the Board's satisfaction her competency to resume practice with skill and safety to patients. Thereafter, any petition or request for reissuance or reinstatement of medical licensure made by Dr. Wilson shall be granted or denied, at the sole discretion of the Board, and on such probationary terms, conditions and/or restrictions as the Board may then deem appropriate. Any reinstatement of Dr. Wilson's license pursuant to section (1)(a) of this paragraph shall include a minimum probationary period of one year.

2. **Effective Date.** This Consent Order shall be effective on the date it is approved and accepted by the Board as shown by the signature of its representative below.

IT IS FURTHER ORDERED that any violation or failure of strict compliance with any of the terms, conditions or restrictions set forth by this Order by Dr. Wilson shall be deemed adequate and sufficient cause, upon proof of such violation or failure, for the revocation and cancellation of Dr. Wilson's license to practice medicine in the state of Louisiana, or for such other action as the Board may deem appropriate, as if such violations were enumerated among the causes provided in La. R.S. 37:1285.

IT IS FURTHER ORDERED that this Consent Order shall be, and shall be deemed to be, a Public Record, and shall likewise be available on the Board's website, <https://www.lsbme.la.gov/>, under "Disciplinary Actions," and shall be reported to the National Practitioner Data Bank ("NPDB").






