CONSENT ORDER

The Louisiana State Board of Medical Examiners (Board) received apparently reliable information from the Mississippi State Board of Health indicating that Raymond Lloyd Brown, M.D. (Dr. Brown) had, over an extended period, been prescribing excessive quantities of controlled substances, including Percodan and injectable Demerol, in other than a legal or legitimate manner. The substantial accuracy of such information was acknowledged by Dr. Brown in writing and in an informal appearance before the Board Secretary. Dr. Brown also advised the Board, consistent with prior information, that he had represented to the Mississippi State Board of Health that he would not, without the prior approval of said Board, apply for or seek renewal or reinstatement of his federal and state license and registration to prescribe or dispense controlled substances.

Upon application by Dr. Brown for renewal of his license to practice medicine in the State of Louisiana, recognizing his right to a hearing pursuant to LSA-R.S. 49:961, Dr. Brown nonetheless waives his right to a formal evidentiary hearing and consents to entry of the following Order. Accordingly,

IT IS ORDERED that Dr. Raymond L. Brown's continuing exercise of any rights and privileges to practice medicine in the State of Louisiana under Certificate No. 9073, is expressly conditioned upon his acceptance of and compliance with the following restrictions:

- A. Dr. Raymond Lloyd Brown, M.D., if he has not already done so on the date hereof, shall surrender to the issuing authorities his state license and federal registration to prescribe, dispense or administer controlled substances and shall not exercise any of the rights or privileges granted or provided for under such licenses and registrations; and
- B. Dr. Raymond Lloyd Brown, M.D. shall not, without the prior written approval of the Louisiana State Board of Medical Examiners make application for any original, duplicate, renewal or reinstatement license or registration to prescribe, dispense, or administer controlled substances.

IT IS FURTHER ORDERED that any violation of the restrictions hereinabove set forth by Raymond Lloyd Brown, M.D. shall be deemed just cause for the suspension or revocation of the physician's licensure or for other disciplinary action as the Board deems appropriate, as if such violation were enumerated among the causes set forth in LSA-R.S. 37:1285.
