Following the reports to the Louisiana State Board of Medical Examiners ("Board") that Cantral Lester Eargle, Jr., M.D., had voluntarily surrendered his license to practice medicine in the State of California, effective September 25, 1985, the Board requested and received certified copies of a formal accusation made by the Board of Quality Assurance of the State of California (No.D-3062) (photocopy attached), together with a document entitled "Surrender of Certificate of Licensure and Formal Acceptance Thereof") (photocopy attached), signed by Dr. Cantral Lester Eargle on July 30, 1985 effective September 25, 1985.

The formal accusation referred to above contains allegations of unprofessional conduct, specifically related to excessive prescribing of certain specified drugs.

Recognizing his right to have the administrative charges adjudicated pursuant to LSA-R.S. 49:955-58 and to a final decision rendered upon written findings of fact and conclusions of law, Dr. Eargle nonetheless waives his right to an administrative adjudication and written findings of fact and conclusions of law and, pursuant to LSA-R.S. 49:955D, enters the following stipulation and agreement.

Accordingly, in consideration of the foregoing and pursuant to the authority vested in the Board by LSA-R.S. 37:1285 and LSA-R.S. 49:955(D),

IT IS STIPULATED AND AGREED that the license of Cantral Lester Eargle, Jr., M.D., to practice medicine in the State of Louisiana, as evidenced by Certificate No. 05706R, be and the same is hereby voluntarily surrendered.
