BEFORE ME, the undersigned authority, personally came and appeared:
DAVID R. ROSENCRANTZ, M.D.
who, after being duly sworn by me, Notary Public, did depose and say that:

Dr. David Richard Rosencrantz hereby stipulates and agrees as follows:

I.

Dr. Rosencrantz is a physician licensed as of this date to practice medicine in the State of Louisiana.

II.

Dr. Rosencrantz practices in the State of Oregon and has no intention of practicing medicine further in the State of Louisiana.

III.

Dr. Rosencrantz is aware that the Louisiana State Board of Medical Examiners (the "Board") has made inquiries and was prepared to take formal action against his Louisiana license particularly because of restrictions, including revocation with stay, imposed on his Oregon medical license by the Oregon Board of Medical Examiners as a result of his

prescribing practices.¹ Dr. Rosencrantz is aware that the Board is empowered so to act by law.²

IV.

Rather than contest any further action by the Board, Dr. Rosencrantz hereby voluntarily and freely surrenders his Louisiana medical license, number 02958R and waives all of his rights under the law: to be formally charged in an Administrative Complaint, to have those charges proved against him by evidence, to appear and confront adverse witnesses, to submit evidence on his own behalf, to have the presence and assistance of legal counsel, to have any further hearing, as well as his rights to appeal the action of the Board, or any other right to which he may be afforded by the Louisiana Administrative Procedure Act, La. Rev. Stat. §49:951, *et seq.*, or otherwise.

V.

Dr. Rosencrantz further stipulates and agrees that any further application for licensure to practice medicine in the State of Louisiana or for renewal of such licensure, which he may file, will be treated in all respects by the Board as if it were an original application by an applicant first seeking licensure with the attendant scrutiny of the Board.

VI.

By his subscription hereto, Dr. Rosencrantz acknowledges and agrees that this Stipulation and Agreement will be and will be deemed to be a Public Record.

VII.

Dr. Rosencrantz waives any right to which he may be entitled by law or otherwise to contest his agreement to, or the force and effect of, this document in any court or other forum relating to the matters referred to herein.

² Pursuant to La. Rev. Stat. §37:1285A(29), the Board may take action against the license of an individual licensed to practice medicine in the State of Louisiana, as a result of: "[T]he refusal of a licensing authority of another state to issue or renew a license, permit or certificate to practice medicine ... in that state or the revocation, suspension, or other restriction imposed on a license, permit, or certificate issued by such licensing authority which prevents or restricts practice in that state"

VIII.

Dr. Rosencrantz stipulates that he has been advised by his own personal legal counsel of the legal effect of this document.

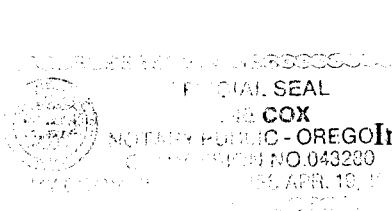


