ORDER

The above-entitled and numbered proceeding has been docketed before the Louisiana State Board of Medical Examiners ("Board") on the Administrative Complaint of Elmo J. LaBorde, M.D., Investigating Officer, alleging that Buddy Roger Siebenlist, M.D. (Respondent) has suffered from addiction to alcohol and narcotics. Accordingly, Dr. Siebenlist is charged with "[h]abitual or recurring abuse of drugs, including alcohol..." and [i]nability to practice medicine with reasonable skill and safety to patients ... because of excessive use or abuse of drugs, including alcohol." La. Rev. Stat. Section 37:1285(5), (25).

On the basis of information provided to the Board and with Dr. Siebenlist's knowledge and consent, the Board is persuaded that the condition from which Respondent suffered may be susceptible to effective medical treatment, resulting in restoration of Dr. Siebenlist's capacity to engage in the practice of medicine with reasonable skill and safety to patients, provided that Dr. Siebenlist strictly observes and complies with reasonable and appropriate restrictions on and conditions to maintenance of his licensure. In consideration of this finding, accordingly, and on the recommendation of the Investigating Officer, the Board has concluded that its responsibility to insure the health, safety and welfare of the citizens of this state against the unprofessional, unqualified and unsafe practice of medicine, La. Rev. Stat. Section 37:1261, will be effectively served by entry of the order set forth hereinafter, by consent.

Recognizing his right to notice of the charges specified against him, to have such charges adjudicated pursuant to La. Rev. Stat. Sections 49:955-58, to be represented therein by legal counsel of his choice, and to a final decision rendered upon written findings of fact and conclusions of law, Dr. Siebenlist, nonetheless, hereby waives his right to notice and formal adjudication of charges, pursuant to La. Rev. Stat. Section 49:959B and acknowledges, accepts and consents to entry of the following order.

Accordingly, in consideration of the foregoing, and pursuant to the authority vested in the Board by La. Rev. Stat. Section 37:1285 and La. Rev. Stat. Section 49:959B;

IT IS ORDERED that, until and unless this Order is modified or rescinded by written order of the Board:

- (a) Strict Adherence to the Terms and Conditions of the Voluntary Affidavit: Dr. Siebenlist shall strictly adhere to, abide by, and comply with all of the terms, conditions and restrictions to which he agreed with the Texas State Board of Medical Examiners, as evidenced by his subscription to Exhibit "A", which is attached hereto, effective April 4, 1988, and incorporated herein by reference.
- (b) Notification of Relocation and Personal Appearance: Should Dr. Siebenlist at any time before the expiration of the five year period, as evidenced by Exhibit "A", or April 4, 1993, whichever occurs first, decide to relocate his practice of medicine to the state of Louisiana, he shall, in that instance, provide written notification to the Board at least sixty (60) days prior to his relocation to the state of Louisiana. Dr. Siebenlist should also personally appear before the Board prior to the time that he commences the practice of medicine in the state of Louisiana.

IT IS FURTHER ORDERED that any violation of or failure of strict compliance with any of the terms and conditions of the Voluntary Agreement entered into by Dr. Siebenlist with the Texas State Board of Medical Examiners (Exhibit "A") or the Consent Order by Dr. Siebenlist shall be deemed adequate and sufficient cause, upon proof of such violation or failure, for the suspension or revocation of the medical license of Buddy Roger Siebenlist, M.D. or for such other disciplinary action as the Board deems appropriate, as if such violations were enumerated among the causes provided in La. Rev. Stat. Section 37:1285.
