CONSENT

ORDER

I, Burnham Charles Strickland, R.T.T., hereby consent to the following terms, conditions, and restrictions upon my license to practice as a respiratory therapy technician in the State of Louisiana. This consent agreement is entered into freely and without coercion of any type. The conditions upon my license to practice as a respiratory therapy technician are as follows:


1. I will attend Alcoholics Anonymous meetings 2 to 3 times a week and obtain a sponsor. The name of my sponsor will be submitted to the Louisiana State Board of Medical Examiners ("Board") no later than 2 weeks from the execution of this Consent Order.
2. I will allow random blood and urine collections/screens for alcohol and drug determination on demand at any time as requested by my sponsor.
3. I will maintain complete and total abstinence of any mood altering chemicals (drug and/or alcohol) for the duration of my life unless prescribed in an appropriate manner for an illness with full agreement from my treating physician and my sponsor.
4. I will attempt to enroll in professional self-help groups dealing with alcohol/drug abuse.

LOUISIANA STATE BOARD OF MEDICAL EXAMINERS

I agree that this contract shall be in effect for a period of 2 years from the date of signing. Additionally, I understand that any violation of the terms, conditions and restrictions set forth herein shall be deemed just cause for the suspension or revocation of my license to practice as a respiratory therapy technician, or for such other disciplinary action as the Board deems appropriate, as if such violation were enumerated among the causes provided in LSA-R.S. 37:3351 et seq, particularly LSA-R.S. 37:3358.
