**STIPULATION AND  
AGREEMENT FOR  
SURRENDER OF  
MEDICAL LICENSURE**

**THIS STIPULATION AND AGREEMENT** is made and executed by Jacob Tasher, M.D. (Dr. Tasher) with and in favor of the Louisiana State Board of Medical Examiners (Board).

1. *Relocation of Practice.* Dr. Tasher stipulates and represents to the Board that he has relocated his practice of medicine in a state other than Louisiana and that he has no intent of resuming an active practice of medicine in the state of Louisiana in the future.

2. *Voluntary Surrender of Licensure.* Dr. Tasher hereby voluntarily surrenders to the Board, for cancellation, his license to practice medicine in the state of Louisiana, as evidenced by certificate no. 04244R.

3. *Reinstatement, Renewal Precluded.* Dr. Tasher stipulates and agrees that he shall not hereafter have any right or entitlement to reinstatement or renewal of his license to practice medicine in the state of Louisiana and he shall not hereafter apply for or otherwise attempt to obtain any original, reinstated or renewed license to practice medicine in the state of Louisiana.
